Measuring

All agility dogs are required to have an Official Jump Height Card or, if your dog is younger than 2 years old, you must have a valid copy of the yellow Agility Measurement Form from a previous measurement. Otherwise,

your dog needs to be measured by the judge of record *before* its first run of these trials. (Exception: Dogs running in 24" and 26" jump heights do not have to be measured.) **A Measuring Official is not scheduled to be at this trial.** Therefore, the measurement is good for this trial weekend only

Check-In

Self-serve check-in will start at 7:00 a.m. all three days. If your dog needs to be measured, please see the trial secretary for your armbands after your dog is measured. **If your dog needs to be measured, it is your responsibility to have it done before you run.** Daily check-in is not required after your first check-in of the weekend.

Running Orders and Course Maps

Each judge will supply course maps. **Please take ONE copy so we will have sufficient copies for every exhibitor.**

Running orders will be posted in the spectator area on the south side of the rings and at the gate. Please check either of these places to determine where you are located in the running order.



Move-Ups:

The pretrial move-up deadline is Monday, November 21 at 6:00 pm. Please email the trial secretary on or before that date/time for a move up for the trial. ntxagility@verizon.net



Day-to-day move-ups are permitted at the trials. You must fill out a move-up form (available at the check-in table) at any time, but no later than 20 minutes after the last dog crosses the finish line on Friday (for a Saturday move-up) or Saturday (for a Sunday move-up). Please give all move-up forms to the trial secretary.

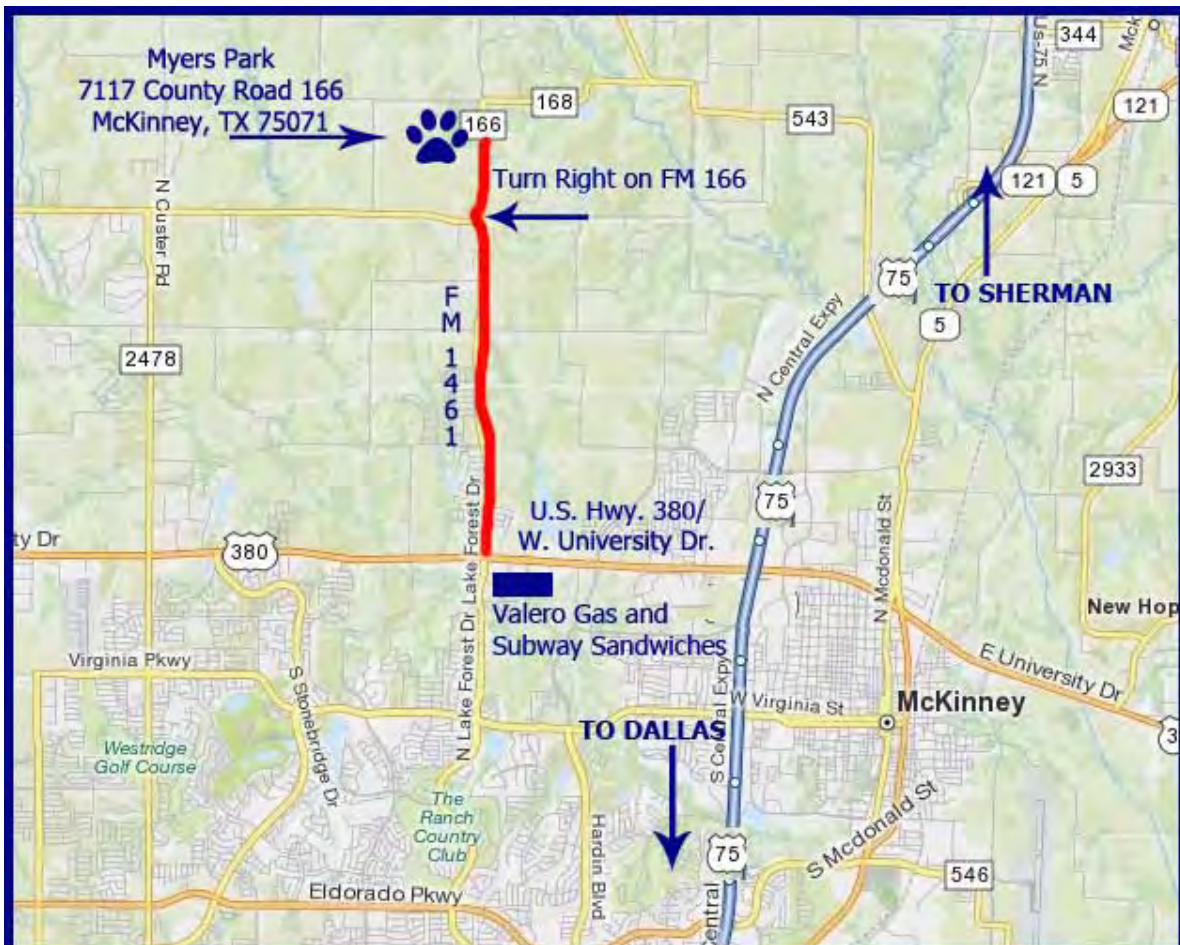

From the north or south: On U.S. 75, take the U.S. 380 exit and go west about 2.5 miles to FM 1461. Turn right (north) on FM 1461 and travel approximately 2.8 miles to County Road 166. Turn right (north) on County Road 166 and go about 0.8 miles (8/10 of a mile) to the site which is on the left.
