Check-In and Measuring Info



Check-in will start at 7:00 a.m. all three days. If your armband envelope is not in the self-serve box, chances are your dog needs

to be measured. You may pick up your armband from the trial secretary after your dog has been measured.

All agility dogs are required to have an Official Jump Height Card and must be able to present it if asked. Don't forget to bring your height card in case someone asks for it

Our judge Laura English is an AKC Measuring Official. All dogs, regardless of jump height, who are under two years of age and do not have a temporary height card (yellow form from a previous measurement) AND dogs who are over two years of age and do not have a permanent height card MUST be measured prior to their first run of the weekend. *Forms will be available at the check-in table. Please fill out a form before requesting to be measured.* If a measurement is necessary, it is the exhibitor's responsibility to have their dog(s) measured prior to running.

MOVE-UPS

Be sure to let the trial secretary know if you've earned a new title since you entered the trial so your dog can be moved up! Pre-trial move-ups must be submitted to the trial secretary via email **no later than 6 PM Monday, December 5, 2011 at 6:00 pm.** Day-to-Day Move-Ups are permitted if you fill out a move-up form (available at the check-in table) and give it to the trial secretary at any time, but no later than 20 minutes after the last dog crosses the finish line on on Saturday.

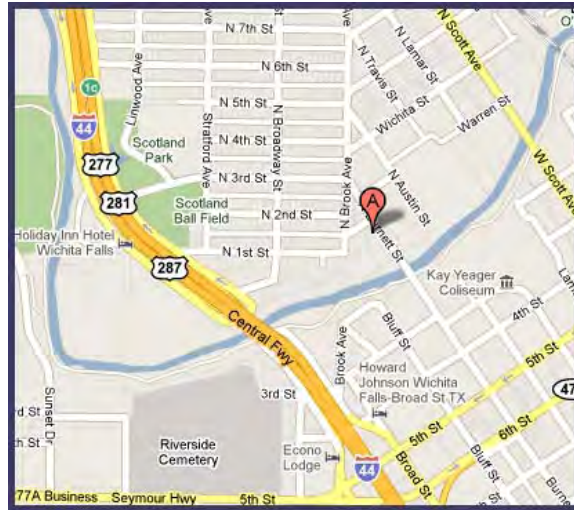

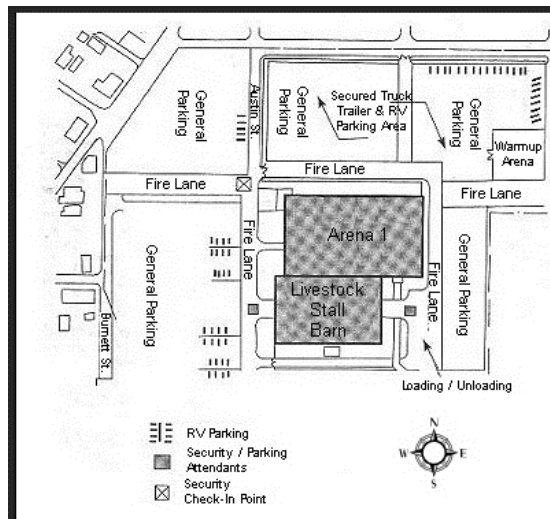
The Trial Site

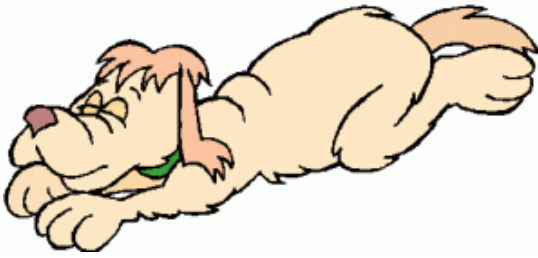

RV parking on site:

Fifty (50) RV spots are available at the J.S. Bridwell complex with water and electricity with a dump station about ½ mile away at a city-owned RV park by the river. The sites are \$17 per night (first come, first served). Personnel from the J.S. Bridwell center will hook up exhibitors and collect the fees.

Exhibitors are responsible for cleaning up after their dogs immediately on hotel/motel and show grounds. Motels/hotels require that dogs be crated when unattended; no bathing or grooming of dogs in guest rooms. Exhibitors/handlers are responsible for any damages to motels/hotels or the event site and may result in disciplinary action by the Trial Committee. Entries may be refused in the future for previous misuse of the motel facilities. This is an AKC-supported measure.

PLEASE REMEMBER: Hotels do not have to allow us to keep our dogs in the rooms. We are all responsible for insuring future pet acceptance at our favorite hotels. Please clean up after your dogs (inside and outside), keep them quiet so as not to disturb other guests, and generally be considerate of others. We all want to continue to have nice places to stay when we travel with our dogs.
