 designatethe particular variety you are entering i.e., Cocker Spaniel (solid color black, ASCOB, particolor). Beagles (not exceeding 13 in. over 13 in. but not exceeding 15 in.). Dachshunds (longhaired,
 smooth, wirehaired), BullTerriers (colored, white), Manchester Terriers (standard, toy), Chihuahuas
 (smooth coat, long coat), EnglishToy Spaniels (King Charles and Ruby, Blenheim and Prince Charles),
 Poodles (toy, miniature, standard), Collies (rough, smooth),
- (Event Class) Consult the classification in this premium list.
